


Lot 111 description:

Beginning at the Northwest corner of Lot 111 of the plat of Oakwood; thence S50°11'45"E, 60.54 feet; thence S29°02'57"W, 159.72 feet; thence N50°49'13"W, 60.79 feet; thence N29°10'48"E, 160.33 feet to the point of beginning (P.O.B.)

Said parcel contains 9,549.1 s.f. (0.22 Acres) of land, more or less and is subject to all easements and rights-of-way of record.
